Metsing evades court

...lawyer says he has no idea where his client disappeared to

MASERU – Mothetjoa Metsing, leader of the Lesotho Congress for Democracy (LCD) is a wanted man after he failed to appear in the High Court on Monday in a matter in which he is challenging to be joined in a case against five soldiers who are accused of among others, the murder of a police officer.

His co-accused, Selibe Mochoboroane who is leader of the Movement for Economic Change (MEC) showed up alone.

The High Court has as a result issued a warrant for Metsing's arrest.

His lawyer, King's Counsel (KC) Motiea Teele told the court that he had no idea where his client was, adding that he last communicated with him on Sunday night.

KC Teele said he was therefore leaving matters in the court's hands, confirming that Metsing was fully aware of Monday's appearance.

Metsing who also the former Deputy Prime Minister together and Mochoboroane who is the Minister of Development Planning have trying to secure immunity from prosecution but all their attempts have been in vain.

The two have had their joinder in the criminal trial delayed following a series of applications, some of which ended up in the Court of Appeal.

Recently, one of their appeals was dismissed by the Court of Appeal, while another one was struck-off the roll.

If joined, they will be accused alongside former army commander Lieutenant General Tlali Kamoli together with Captain Litekanyo Nyakane, Lance

Corporals Motloheloa Ntsane and Leutsoa Motsieloa.

The five soldiers are accused of the murder of Sub-Inspector Mokheseng Ramahlolo during an incident that occurred at the Police Headquarters in Maseru on August 30, 2014.

Mochoboroane charged alongside accused soldiers

...judge rules that charges against the two political leaders stand

MASERU – Selibe Mochoboroane, the Minister of Development Planning was on Monday joined in a case against five soldiers who are accused of among others, treason and the 2014 murder of Police Sub Inspector Mokheseng Ramahlolo.

The leader of the Movement for Economic Change (MEC) was expected to appear before Chief Justice Sakoane Sakoane alongside his co-accused Mothetjoa Metsing, who has since disappeared.

But Mochoboroane came to court alone after the elusive Metsing failed to turn up.

Metsing who is leader of the Lesotho Congress for Democracy (LCD) and former Deputy Prime Minister is now a fugitive after the High Court on Monday issued a warrant of his arrest.

His lawyer, King's Counsel (KC) Motiea Teele told the court that he had no idea where his client was, adding that he last communicated with him on Sunday night.

KC Teele said he was therefore leaving matters in the court's hands, confirming that Metsing was fully aware of

Monday's court appearance.

Mochoboroane came to court after an application he and Metsing had earlier filed was dismissed in which they were challenging the decision of the Director of Public Prosecution (DPP) to summarily indict them.

The court had in the judgment ruled that the reasons for challenging the decision do not pass legal muster. It had also concluded that the decision to join them for summary trial in the criminal case against the five accused soldiers stands.

A charge sheet detailing 10 charges against Mochoboroane together with former army boss, Lieutenant General Tlali Kamoli and Captain Litekanyo Nyakane, Lance Corporals Motloheloa Ntsane and Leutsoa Mtsieloa was read in court on Monday.

The accused face a battery of charges including treason, murder, attempted murder and aggravated assault which allegedly occurred sometime in August 2014 in Maseru.

Smallpox is officially declared eradicated

On December 9, 1979, a commission of scientists declare that smallpox has been eradicated. The disease, which carries around a 30 percent chance of death for those who contract it, is the only infectious disease afflicting humans that has officially been eradicated.

Something similar to smallpox had ravaged humanity for thousands of years, with the earliest known description appearing in Indian accounts from the 2 Century BCE. It was believed that the Egyptian Pharaoh Ramses V died of smallpox in 1145 BCE; however, recent research indicates that the actual smallpox virus may have evolved as late as 1580 CE. A type of inoculation - introducing a small amount of the disease in order to bring on a mild case that results in immunity - was widespread in China by the 16th century.

There is no record of a smallpox-like illness in the Americas before European contact, and the fact that Europeans brought pox with them was a major factor in their conquest and near-eradication of many of the indigenous peoples of North, South and Central America. Smallpox was the leading cause of death in 18th century Europe, leading to many experiments with inoculation. In 1796 the English scientist Edward Jenner discovered a vaccine. Unlike other types of inoculation, Jenner's vaccine, made from a closely-related disease that affects cows, carried zero risk of transmission.

Many European countries and American states made the vaccination of infants mandatory, and incidents of smallpox declined over the 19th and early 20th centuries. Compared to other epidemic diseases, such as polio or malaria, smallpox eradication was relatively simple because the disease lives only in humans, making human vaccination highly effective at stopping its spread, and its symptoms appear quickly, making it easy to identify and isolate outbreaks.



MASERU – Standard Lesotho Bank (SLB), has invested a total of M650 000 into a newly launched bursary fund targeted at economically challenged high school learners. Dubbed the Standard Lesotho Bank Bursary Fund, the programme is intended to support 50 academically gifted pupils from less privileged families to assist them in acquiring high school education.

“As a bank we look at ourselves as a corporate citizen and we have an obligation to give back to the community. The fund is also in line with the National Strategic Development Plan II of the government of Lesotho and the Sustainable Development Goal 4 of the United Nations towards ensuring inclusive and equitable quality education and promote lifelong learning opportunities for all,” Standard Lesotho Bank Acting Head of Brand and Marketing, Manyathela

Kheleli said during the launch last week. The fund is further intended to promote academic excellence and shape the next generation of Basotho’s talent in order to build national capacity and local human capital to make a meaningful contribution to the country. The SLB Bursary Fund will commence in 2022 with the initial capital injection of M650 000 to cover all tuition fees and living expenses of qualifying learners.

It is intended for academically gifted pupils from families with a combined monthly income of less than M3 000 per month, at any high school class until they finish their LGSCE examination. “To be eligible and qualify for the programme, an applicant has to be a Mosotho learner at high school level with an average performance of 70 percent or higher. Such learners have to be from less privileged families and not sponsored by another organisation,” said Maria Sefuba Jonase from SLB department of Technology and operations during the same event. The fund further incorporates career guidance, mentorship and psycho-social support to recipients during the tenure of their sponsorship. It is free and open to qualifying Basotho nationals in

all the districts who meet entry requirements. Among its main objectives, the programme is intended to decrease the numbers of pupils who drop out of school, especially at high school level due to financial constraints. The fund has been recognised by the bank as an initiative that has potential to address the plight of gifted but economically challenged Basotho children who lose out on the potential to be future leaders in the country. It also responds to a gap in universal access to education, where the government currently provides free primary education and scholarships for tertiary education. The fund is a pilot project for a period of three years and it will start with the first cohort of 50 learners for 2022.

RNB Properties Ltd deserves a pad on the shoulder

RNB properties Limited should be lauded for being the first local company to list its ordinary shares on the Maseru Securities Market (MSM), roughly five years after the revered body was established.

On Monday this week, the Central Bank of Lesotho announced the property outfit's decision to be the first in listing its ordinary shares on the main platform of MSM, which simply translates into the fact that all issued shares of the same class can now start trading on MSM, thus offering the existing investors an opportunity to sell their acquisition and the potential ones an opportunity to buy shares on the regular market where the company valuation and the price of its shares will be driven by market fundamentals.

The listing marks an important and significant milestone in the development of capital markets in the country, more specifically the development of equity market and the exchange. This move is commendable because a lot of other companies in Lesotho are not particularly keen to follow the same direction for a number of reasons that include lack of willingness to be subjected to the corporate governance standards, among others.

With the stringent economic conditions in the country, dominated by lack of skills, industry related education and training as well as access to finance, listing could be a perfect platform for local companies to solve some of these problems.

Companies should see this as a perfect opportunity to raise the much-needed capital for their business expansion. In this way the struggling local private sector could also realise the much needed growth hence more opportunities and job reaction.

Of course the journey towards listing may be both vexing and tedious, but considering the benefits that come with it, companies should demonstrate passion and willingness to join the RNB Properties in doing the right thing. In many more years to come, the company will be remembered as the pioneer in this regard, opening doors for more investment opportunities in the long run.

On the other hand, staying private essentially means that a company's shares are not traded on the public stock market. Shares are held by the company founders, their families or some selected group investors. If you want to buy shares in such a firm, you have to make a request to the existing owners.

Staying private also avoids burdensome disclosure requirements from stock exchanges and some companies fear that a small slip up due to perhaps lack of diligence could lead to troublesome interest from regulators, or even expulsion from a stock exchange.

Arare and lengthy media conference was held by some in the leadership of the National Prosecuting Authority on Monday 6 December 2021. Conspicuously absent was Hermione Cronje, head of the Investigating Directorate set up by President Cyril Ramaphosa's proclamation in 2019 to plug the yawning gaps in the anti-corruption machinery of state he was shocked to find on taking office.

Cronje has resigned for many reasons, none of which were revealed or discussed in anything like the detail the media questions demanded during and before the conference.

A visit to the website (undertaken in a vain effort to find the time of the conference) of the NPA is as underwhelming as the content of the media briefing. There is not a word about it to be found; it hasn't been updated since October and the media statement of Shamila Batohi, National Director of Public Prosecutions, on its "quick links" section is dated February 2019.

Her statement then, marking her appointment, was upbeat and full of eager anticipation of the tasks ahead. Her performance on 6 December is markedly different. There are those who measure the efficiency and effectiveness of organisations by the state of their websites.

Perhaps the most remarkable feature of the uninspiring media conference is the failure of all participants to get to grips with the real issues. It is common cause that anti-corruption work is specialised, difficult and urgently needed if South Africa is to avoid falling into failed state status. The overwhelming impression is that Cronje quit in frustration or desperation at being unable to do what is required to get on top of rampant serious corruption, the ravages of State Capture, the calumny of insurrection and 'covidpreneurism', all fueled by the kleptocrats of the Zuma era and beyond.

Cronje's repeated refrain that her work was being undermined by saboteurs within the NPA, planted there to ensure ongoing impunity, was, for the first time, denied by Batohi who, contradictorily so, admitted to the existence of pending disciplinary matters involving disloyalty in her staff. She ducked giving details.

There are three fundamental issues that should have been and

still need to be addressed but weren't.

The relevant topics can be raised by parliamentarians when the minister of justice joins Batohi to explain the mess to them on Wednesday 8 December. Less obfuscation and more focus can be extracted, if the right topics come up for discussion, which did not happen on 6 December.

The first of these topics is the decisions of the courts as they appertain to the corruption-busting responsibilities of the state via the criminal justice administration. These decisions set out, loudly and clearly, the binding requirements (known as the Stirs rules) of the law; they specify the criteria by which an anti-corruption entity is to be measured and they set the parameters of an effective and efficient structure whose operations are capable of discharging the treaty obligations of the country and its commitments to respect and protect the human rights of its population, especially those human rights that are expensive to deliver to the poor.

The loot of State Capture is diverted away from social grants, healthcare, housing, education and other human rights that are intended by the Constitution to create a better life for all. Corruption busters are meant to reverse the flow of the loot and hold the looters to account in court. These good outcomes are simply not happening in SA because a blind eye is being turned to the basic and binding requirements for success in corruption busting. The Glenister trilogy of cases, fought hard between 2008 and 2014, set out what is needed. They did not feature in the discussions of the NPA leadership at all. On the contrary, some revealed a mindset that harkens back to the dark days of the Zuma era during which the fragmentation and destruction of the corruption-busting capacity of the state was the order of the day.

The numbers are revealing: the Scorpions had over 500 members, the ID has about 120, many of whom will follow their leader into resignation unless urgent action is taken now to reassure them. The ID is not permanent, it serves at the pleasure of the president, Cabinet and Batohi; it lacks independence, resources, skills needed and freedom from political influence and interference in its work. It ought to have a reporting line directly to Parliament, but does not. DM

Capital sources required to support financial capital – Khasipe

MASERU – Thabo Khasipe, the Commissioner General of the Lesotho Revenue Authority (LRA), an organisation that is responsible for the assessment, collection and remittance to the Government of public revenues in Lesotho says innovations form part of the main priorities of LRA and in as much as they work with money, it is financial capital which needs to be supported with other sources of capital. He was speaking at the end of a three-day LRA Hackathon open platform for young innovators, which ended in Berea on Tuesday.

As part of the event, the LRA also held the Hackathon open platform competition for the innovators and Team Veteran walked away with the first prize, winning cash worth M30 000.

The competition was intended to strike strategic partnership with key stakeholders in order to invite innovative ideas and processes which can be implemented to address compliance issues.

Mr Khasipe said it is possible that the LRA is the first revenue authority in the region to host such an event, adding that if the innovators could design beautiful systems, they could sell such ideas to the rest of Africa because tax revenue systems are the same in most countries.

“We are overwhelmed by the support from our sponsors who included Vodacom Lesotho, ECONET and African Tax Administration Forum (ATAF),” he said.

Acknowledging all participants, the Commissioner General said they should be proud of themselves, congratulating the winners for their hard work and commitment as well as the judges for a job well done.

Bokang Thola of Team Veteran expressed his gratitude to the LRA on behalf of his teammates for pioneering such an august event.

“I also wish to applaud the sponsors for coming up with such an innovative project and we wish that other organisations and companies could embrace innovation in a similar manner. We have also learnt a lot, more especially about tax issues and other new technologies,” he said.

Mr Thola added: “Indeed we feel honoured to have been granted such an opportunity to be part of this big event and to eventually win the competition.”

Tumisang Liphoto, who was one of the judges in the competition, said some of the challenges they encountered included people who did not present their architectural systems.

He said most of the solutions which were proposed were taken for granted, adding that it is not easy to get access to data.

Mr Liphoto said most of the data was unstructured, adding that many presenters were not able to tell how and why they had selected a certain model.

However, he said most of the solutions presented by the participants were brilliant and worthy for the LRA to implement.

The runners up in the competition were Finhack Team and they pocketed a sum of M20 000 while Team Morogo appeared third collecting M10 000. LeNA

MOHALE'S HOEK – WORLD Vision's Area Programme Coordinator, Tšepo Motsamai says access to COVID-19 Tools Accelerator (ACT-A) is an unprecedented initiative that brings together governments, scientists, businesses, civil societies, philanthropists and global health organisations to address this challenge and protect everyone from the virus.

He made these remarks on Saturday in Phamong, Mohale's Hoek where the World Vision through the World Health Organisation (WHO)'s technical and financial support held training for health centre committee members based in the southern region district.

The event was aimed at addressing the country's specific health systems' bottlenecks to enhance readiness for the delivery of COVID-19 tools.

Mr Motsamai who is based at the World Vision office in Mohale's Hoek said a global response to COVID-19 pandemic requires deployment of novel technologies everywhere they are needed.

The project, he said was aimed at contributing towards improved community access to relevant COVID-19 response interventions.

He said since the first COVID-19 case was recorded, different efforts were made to curb the spread of the fatal virus, adding that one of the key areas that make a gap from infection prevention to vaccines is education.

"There are a lot of misconceptions surrounding the safety of the vaccines, therefore we want to empower communities with COVID-19 preventive messages and mental health education during the pandemic, in order to curb the spread of the virus and the secondary impact," he said.

He said they have health centre committees built of members of the community who include a teacher, the area chief, youth and a traditional healer who support the clinic to run its daily operations.

"Besides supporting the clinic, the team also assists the initiatives at the height of the pandemic and it is our responsibility to investigate some of the social and health issues in the community," he said.

Working together with the Water, Sanitation and Hygiene (WASH) teachers, Mr Motsamai said they came to realise that WASH plays an important part in the fight against the virus, adding that one of the key components in preventing the spread of the virus is consistent washing of hands.

"We work with WASH teachers to understand the type of messages about COVID-19 that need to be given to learners.

"The WASH teachers are also responsible for WASH related messages and to ensure that correct information is passed to the WASH Clubs," he also said.

The purpose of the ACT-A is to support the development and equitable distribution of diagnostics, treatments, vaccines and protective personal equipment to reduce mortality and severe disease, restoring full societal and economic activity globally.

WHO is a co-host of the ACT-A Facilitation Council that includes founding ACT-A members and donors, market

shapers and regional cooperation groups.

It is also a secretariat member of all four ACT-A work pillars: vaccines, treatments, diagnostics and health systems connector (HS-C).

Thato Mxakaza from WHO said there is need for individuals to work hand in hand with both governments and non-governmental organisations in order to beat the virus.

"If we want to win the battle against the pandemic, it is everybody's responsibility to fight it and to deliver a better life for everybody," he said.

As a crisis multiplier, COVID-19 continues to exploit and deepen inequalities, disproportionately putting more lives in jeopardy in the world's toughest places. Devastating aftershocks pose immense, additional threats to physical and mental health, safety, food and security, and education.

The forcibly displaced, especially children, are some of the most affected by the pandemic's indirect impacts. Access to the vaccine is therefore paramount in preventing the immediate and long term aftershocks of COVID-19 on children, who are experiencing multiple levels of deprivations, with their health, education increasingly affected by the impact of COVID-19 on their parents and caregivers.



"I am studying this and soon planning to make a law that the horns of all vehicles should be in Indian musical instruments so that it is pleasant to hear," Nitin Gadkari told local media recently.

The hooters could blast sounds made by the flute, tabla, violin, mouth organ or harmonium, he added.

Gadkari also said he wanted to replace the "irritating" sirens used by ambulances and police vehicles with soothing tunes.



USA

Donald Trump didn't want to build a golf course in Africa because he was 'too scared of lions'

Being a "pretty thick guy", former US president Donald Trump did not want to build a golf course in Africa because he was too scared of lions, a new book claims.

Trump, who was surprised that lions couldn't jump over high fences, revealed his fear of lions during a round of golf with South African legend Gary Player, a nine-time Major champion, according to revelations in *Peril*, a book authored by Bob Woodward, an associate editor at *The Washington Post*, and Robert Costa.

The conversation took place as Player tried to help Trump with his swing and told the then president to use more "control", and said he should be "toning it down, swinging less extravagantly".

Trump is a keen golfer and began acquiring and constructing golf courses in 1999. By the time of his election as US president in 2016, he owned 17 golf courses.

Player then reportedly encouraged Trump to expand his golf and hotel empire to Africa. However, Trump was not impressed with the idea, the book claims.

Sausage vending machines booming in Germany

Some of the machines sell three or four varieties - alongside punnets of potato salad.

Hungry Germans craving a sausage in the dead of night are increasingly turning to vending machines for their bratwurst, bockwurst, and barbecue meats.

The machines are "booming" outside German cities where shops are less likely to stay open for long hours, according to a survey by the German.



USA

Woman addicted to eating her own hair has giant hairball 'with tail' removed from her stomach

A woman who was addicted to pulling out and eating her own hair had a giant hairball measuring 15 centimetres removed from her stomach, according to a medical journal.

The 38-year-old, who was suffering from nausea, vomiting and an extremely swollen abdomen when she arrived at hospital in the US, had suffered dramatic weight loss, losing 15 pounds over the previous eight months after she lost her appetite.

The unnamed woman was rushed into surgery, where a giant hairball was found lodged in her digestive tract, with a small "tail" of hair trailing into her intestines and a second four centimetre hairball nestled deeper in her bowel.

She was found to be suffering from the rare Rapunzel Syndrome, which has only ever been documented 88 times in medical literature.



SUDAN

Row over phone causes Darfur violence - officials

Officials in Sudan say nearly 50 people have been killed in ethnic clashes in the western region of Darfur.

They said the trouble in the town of Kreinik started with an argument about a mobile phone which spiralled into violence.

Fighting between Arab and non-Arab communities in Darfur has escalated in recent months.

Drink sensibly over the festive season – nutritionist

...because individuals differ, specific effects of alcohol on them will also vary

LERIBE – During the Christmas and New Year season, several musical festivities, parties, family gatherings, work functions and barbecues are held.

Many people look forward to celebrations during the holidays, yet it is also a time when others drink beyond measure.

This week Metro chats with local nutritionist, Bennett Ketelo, (a food and beverages expert) on how to properly use alcohol during this season and throughout the year.

He says: "While it is a great time of the year, it can also be a time of excess, especially when it comes to alcohol. Some people will suffer adverse consequences that range from fights to car crashes. It is particularly important to take measures to protect ones' health and their loved ones."

Because individuals differ, he says specific effects of alcohol on them will also vary.

"But certain facts are clear, there's no way to make good decisions when you are intoxicated and there's no way to sober up faster," Ketelo warns, advising alcohol users not to underestimate the effects of alcohol.

"Do not believe you can beat them, or they may beat you. Think before you drink, and practice measures to limit your intake," he cautions.

For those who plan to host holiday gatherings, he says it is imperative to offer a variety of nonalcoholic drinks, including water, juices and sparkling sodas.

"Nonalcoholic drinks help counteract the dehydrating effects of alcohol. Also, other fluids may slow down the rate of alcohol absorption into the body and reduce the peak alcohol concentration in the blood. They also provide your guests with alternatives to alcohol," he further shows.

"Also provide a variety of healthy foods and snacks. Food slows down the absorption of alcohol and reduces the peak level of alcohol in the body by about one-third. Food can also minimise stomach irritation and gastrointestinal distress the following day," he says.


He adds: "After the party, help your guests get home safely - use designated drivers and taxis.

Anyone getting behind the wheel of a car should not have ingested any alcohol. If you are a parent, understand the underage drinking laws—and set a good example. Have a safe holiday season."

The fact is no one intends to be harmed when they celebrate during the holiday season, yet violence and traffic fatalities associated with alcohol misuse persist, and myths about drinking live on—even though scientific studies have documented how alcohol affects the brain and body.


Studies by various centres for disease control and prevention around the world show that alcohol can also cause blackouts—which are gaps in a person's memory while they are intoxicated. These gaps are described to happen when a person drinks enough alcohol to temporarily block the transfer of memories from short-term to long-term storage—known as memory consolidation.






Sudoku Puzzle

MASERU – Bantu FC head coach, Bob Mafoso has admitted to having a selection headache over his depleted squad after several of his charges were reported

to have gone AWOL as the club prepares to return to action this weekend.

The defending league champions will face LDF in a

catch-up match this weekend after the Vodacom Premier League recently made a return following the long layoff.

Players such as Bokang Sello,

Lekhooa Khoete and Keamogetse Wolf are reported to have gone absent without leave since the team returned to training over a month ago.

Bantu currently have no natural left-back in their squad having also parted ways with South African born Lebohang Shelleng, who joined them after impressing during his time at Lioli.

“We are called a big team because of the resources that we have and anything that depletes our squad leaves us worried because we have little options,” Mafoso said.

“Our team used to boast about having an even left footed centre-back that gave us a good balance, but we are a big team and still have the quality to adapt to the current situation,” he said.

The Bantu mentor said his side will have to find ways to grind results without a natural left-back as they aim to defend their league title.

“Of course, it will be different without a natural left-back, but we have to find a way to play without it and still get the right balance in the team,” he said.

“It worries us a lot that we do not have a natural left back, but like I said, we are a big team, and we will have to make do with what we have now and get the best out of it.

“We were supposed to return

last weekend against Linare, but the match was postponed due to heavy rain and I think the team is ready to return to action now.

A Matšo Matebele are also still preparing for life without their last season top goal scorer, Litšepe Marabe, who left the country a few months ago for a new adventure with an Indian outfit, Royal Basco FC.

Marabe contributed hugely to Bantu’s successes since joining the club almost eight years ago after an unsuccessful spell with the now defunct South African side, Garankuwa United.

He was the league lead goal scorer last season as the Mafeteng-based outfit nearly went the whole season unbeaten, scoring 14 goals to walk away with the golden boot award.

The left-footed forward was again at the top of the goal scoring charts in the Vodacom Premier League when football activities were halted by the COVID-19 pandemic earlier this year.

Weekend’s matches will also see last season runners-up Matlama FC return to action with a clash against LCS at the LCS Ground while Swallows will host Lijabatho and Sefothafotha welcome LMPS at the Ratjomose Military Barracks.

Lesotho taekwondo team loses to Eswatini in AUSC finals

MASERU - After collecting three gold medals in the semifinals of the ongoing African Union Sports Council (AUSC) Region 5 Games on Monday, the Lesotho taekwondo team on Tuesday lost to their Eswatini counterparts in the finals to settle for silver medals.

The three gold medals came through Liteboho Motsosi in the women's bantam

weight division (46kg), Mpho Mofammere in the men's fin weight class (45kg) and Karabo Thokoa in the men's lightweight category (59kg).

Lesotho coach, Puseletso Lekanyane told Metro on Tuesday that his charges could have won numerous gold medals had they not put themselves under unnecessary pressure.

"My charges put themselves under pressure on Tuesday following the three gold medals they collected on Monday. They were desperate to win by all means.

"I had however, not expected the kind of performance they displayed. We started training for this competition during the COVID-19 lockdowns but we did not have enough time as we only trained a day and half per week. We camped towards November. My charges are all new to international competition. One of them was shortchanged and his points were given to an opponent. I have only three players who are still in the tournament and will be in the finals."

Monaheng Khebe failed to compete in

the men's 60kg semifinals on Tuesday after he weighed 61kg during the weighing-in on Monday.

The Lesotho Taekwondo Association (LTA) Public Relations Officer, Sek'hok'he Molikoe said the athlete lost the semifinal match as per the taekwondo regulations.

The AUSC Region 5 Maseru 2020 Games commenced on December 1 with the football competition while the other sporting codes followed some days later. The regional games end on December 12.

"The administration course is also dominated by females who have taken 16 slots with only four going to their male counterparts," he said.

Kalati noted that the regional body kick-started its legacy programmes with a referee's course which included 15 local match officials, adding that three of them have been appointed to officiate at the ongoing 2020 AUSC Region 5 Games in Maseru.

He said on Saturday, COSAFA collaborated with LeFA to hold the COSAFA -15 girls' legacy tournament for the 10 districts at the Bambatha Tšita Sports Arena in Maseru. Both the semifinals and final were held on Sunday.

Kalati further showed that LeFA's female Assistant Referee, Polotso Maapara officiated the U-20 World Cup qualifier between Zambia and Ghana played at the Nkloma stadium in Lusaka Zambia over the weekend.

He said Maapara was the Second Assistant Referee working alongside South Africa duo of Akhona Makalima and Maneo Tau as the Central referee and First Assistant Referee respectively.

He said Joyce Seonyatseng from Botswana and Rusina Majo of Zimbabwe were the Fourth official and the Match Commissioner respectively. LeNA


The versatile footballer, coach, actor - Doctor Khumalo



THEOPHILUS "16v" Doctorson Khumalo born June 26, 1967), also known as Doctor Khumalo, is a South African former soccer player. He is best known for being a star midfielder for Kaizer

Chiefs as well as the South African national team, the Bafana Bafana.

Having started playing soccer in 1984 with Swallows Reserves, Khumalo then went to Kaizer Chiefs, where he initially

played for the junior team. His father, Eliakim Khumalo, a renowned player of the 1970s and early 1980s, served as his mentor. Khumalo was promoted to the senior team by Coach Ted Dumitri the following year, when he started a game against arch rivals Orlando Pirates.

Khumalo went on to become a star player for Kaizer Chiefs and did not play for any other South African soccer club, only leaving them for short overseas playing periods – he signed with FIFA agent Marcelo Houseman who first took him to Argentinian club Ferro Carril Oeste for six months in 1995, while in 1996 and 1997 he played for the Columbus Crew of the Major League Soccer.

The high-point of Khumalo's soccer career was the 1990s - he was part of the Kaizer Chiefs teams that won three South African league championship titles and five knockout trophies and was also voted South African Footballer of the Year in 1992. During his career at the club, he played in a total of 397 league and cup games, scoring 90 goals.

After the re-admission of South Africa to FIFA in 1992, Khumalo was selected to be a member of the South African squad for its first official international match in July of the same year, against Cameroon. South Africa won the match 1-0, due to a penalty scored by Khumalo. He was also a leading member of the winning South African national team at the 1996 African Nations Cup. He also represented South Africa in the 1998 Football World Cup. Throughout his whole international career, he played for South Africa 50 times (twice as captain), scoring nine goals, making him the 13th most capped South African footballer.

One of Khumalo's most memorable games was perhaps the 1996 Mandela Cup match, where South Africa (Bafana Bafana) played against Brazil. Phil Masinga scored the first goal from Doctor Khumalo's corner kick. Khumalo then scored the second goal to make the score 2-0 in favour of the South Africans. Unfortunately for Bafana, Brazil came back in the second half, scoring three goals, to win the encounter 3-2.

He retired in 2002 and then in 2004 as a player-coach. Although he was a winning co-coach (with Donald "Ace" Khuse) of Kaizer Chiefs in the 2002-2003 season (guiding the club to a 12-game unbeaten record and earning themselves a joint Coach



of the Month PSL award), Khumalo has stated that his aim is to become a soccer administrator. Since 2004, Khumalo served as a television soccer commentator and presenter, being named afterwards South African Under-17 national coach.

Khumalo was voted 62nd in the Top 100 Great South Africans in 2004. He is married to Namibian beauty queen Blanche Garises.

He has SAFA Level 1, Level 2 and Level 3 coaching licenses, an English Football Association license which he obtained in 2005 and a UEFA B license through the German Football Federation in 2007. He previously worked as head coach for the Kaizer Chiefs Under-17 team and together with Khuse. He is the assistant coach for Kaizer Chief

Khumalo made his film acting debut with the German/South African production Themba. He plays

himself as the coach of the under 21s. The movie is about Themba, a young and ambitious football youth, who is faced with poverty, AIDS and violence, but eventually, makes his way on to the South African national team. The film is based on a novel by Lutz van Dijk and premiered at the Berlinale 2010. WIKIPEDIA
